

## The le Royaume-Uni to les Philippines Free Transaction Promotion

### Terms and Conditions:

- To be eligible for the UK to **les Philippines** Free Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's free transaction-branded landing page and successfully complete your first transfer to **les Philippines**.

- **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.**

- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion.
