

****The États-Unis to Special FX + Two (2) Fee-Free Transaction Promotion****

- To be eligible for the États-Unis to Special FX + Two (2) Fee-Free Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from États-Unis to during the Promotion Period (a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.
