

## The États-Unis to Haïti Fee-Free + Discount Transfer Promotion

### Terms and Conditions:

- To be eligible for the États-Unis to Haïti Fee-free + Discount Transfer promotion (“Promotion”) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer which must be from États-Unis to Haïti during the Promotion Period (a “qualifying transfer”).

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered “successful” transactions.

- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

- **Fee-free transfer conditions.**

- The 0 fee transfer will be directly applied to your first successfully completed transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

- **Transfer Discount conditions**

- The \$ transfer discount will be applied by Remitly directly to your first qualifying transfer when you send \$ or more and will be available only to that transfer if it is successfully completed.

- Please note that your discount amount will not count towards the minimum spend requirement.

- The transfer discount cannot be used on subsequent transfers.

- This Promotion has no cash value and cannot be transferred.

- The Promotion begins on mars 14 2025 at 9:00 AM Pacific Standard Time and ends at 5:00 PM Pacific Standard Time on décembre 31 2025 (“Promotion Period”). Remitly’s server is the official clock for this Promotion. All dates are subject to change. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.

- Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods will void and disqualify the customer from receiving the Promotion at Remitly’s sole discretion (acting reasonably).
