

The États-Unis to Honduras Fee-Free on First Transfer + Discount on Second Transfer Promotion

Terms and Conditions:

- To be eligible for the États-Unis to Honduras Fee-Free on First Transfer + Discount on Second Transfer promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer and second transfer from États-Unis to Honduras during the Promotion Period (each a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The 0 fee transfer will be directly applied to your first successfully completed transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

- Once you have successfully completed your first qualifying transfer, The \$5 transfer discount will be applied by Remitly directly to your second successfully completed qualifying transfer when you send \$30 or more .

- Please note that your discount amount will not count towards any minimum spend requirements.

- The transfer discount cannot be used on subsequent transfers.
