

## The États-Unis to les Philippines Transfer Discount & Zero-fee Transaction & Special FX Promotion

### Terms and Conditions:

- "To be eligible for the États-Unis to les Philippines Transfer Discount and Zero-fee Transaction and Special FX promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer to [RECEIVE COUNTRY]] and successfully complete a transfer to les Philippines.

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the cash sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

- **Transfer discount conditions.**

- The \$ transfer discount will be applied by Remitly directly to your qualifying transfer[ and will be available only to that transfer if it is successfully completed.

- Please note that your discount amount will not count towards the minimum spend requirements.

- The transfer discount cannot be used on subsequent transfers.

- **0 fee transfer(s).**

- The 1 (one) 0 fee transfer will be directly applied to your first successfully completed transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

- **\*Special FX conditions.\***

- The special foreign exchange rate will be applied by Remitly directly to your qualifying transfer up to \$1000 (the "Promotion Cap").

- If you send below the Promotion Cap, the special foreign exchange rate will not be applied on subsequent transfers.
