

## Terms & Conditions

- "To be eligible for the Discount + Two (2) 0 Fee Transfers Promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer to Philippines.
- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the cash sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.
- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.
- **Transfer discount conditions.**
  - The transfer discount will be applied by Remitly directly to your qualifying transfer[ and will be available only to that transfer if it is successfully completed.]
