

## **The Namibia FX Boost + \$ Transfer Discount Promotion**

### **Terms and Conditions:**

- To be eligible for Canada to Namibia FX Boost + \$ Transfer Discount Promotion (“Promotion”) you must sign up for Remitly through Remitly’s referral-branded landing page and successfully complete your first transfer to Namibia (e.g., a “qualifying transfer”).
  - A transfer is considered “successfully completed” when funds are deposited into your intended recipient’s bank account; are picked up by your recipient at a cash pick-up location; properly delivered to the recipient and/or deposited into the recipient’s mobile wallet (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered “successful” transactions. If the transaction is not successfully completed, the Special FX Rate available at the time of initiation will not be applied to any future transfers.
  - **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer. This is a limited time offer.**
    - Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods, will void and disqualify the customer from receiving the Promotion at Remitly’s sole discretion.
    - The Promotion will entitle eligible customers to benefit from: (a) the application of a discount of \$ to their transfer amount; and (b) one (1) transfer of up to \$ at the foreign exchange rate (the “Special FX Rate”) published on Remitly’s Special FX branded landing page or mobile application that linked to these Terms and Conditions, as that rate was published at the time that the qualifying transfer is submitted by you.
    - **Transfer Discount & Special FX Rate Conditions.** Provided you have submitted a qualifying transfer on your first transaction, Remitly will automatically apply the \$ discount to and the Special FX Rate to that transfer. The \$ Transfer Discount and Special FX Rate will be applied by Remitly directly to your qualifying transfer and will be available only to that transfer if it is successfully completed. Transfers submitted outside of the

Promotion Period will not be eligible for this Promotion.

- The Special FX Rate is subject to change from time to time at Remitly's discretion.
- The Transfer Discount and Special FX Rate cannot be used on subsequent transfers. The Transfer Discount and Special FX Rate have no cash value.
