

The Transfer Discount Offer Code Promotion

Terms and Conditions:

- To be eligible for the Transfer Discount Offer Code promotion ("Promotion") you must redeem the respective transfer discount offer code via the notification from Remitly that linked you to these terms or enter the respective transfer discount offer code at a "Redeem Offer" or "Apply an Offer" page when signed in to your Remitly account and successfully complete a transfer during the Promotion Period as more fully described in the transfer discount offer code messaging that linked you to these terms (such successfully completed transfer is a "qualifying transfer").

- Transfer Discount Offer Code Conditions. After you redeem the respective transfer discount offer code for this Promotion, the respective transfer discount will be applied by Remitly directly to your next qualifying transfer if it is successfully completed during the Promotion Period. eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive.
