

## **\*\*The Spain to Peru Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the Spain to Peru Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Spain to Peru during the Promotion Period (a "qualifying transfer").
