

## **\*\*The United Kingdom to Special FX + Two (2) Fee-Free Transaction Promotion\*\***

- To be eligible for the United Kingdom to Special FX + Two (2) Fee-Free Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from United Kingdom to during the Promotion Period (a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.
