

The United States to Nicaragua Fee-Free on First Transfer + Discount on Second Transfer Promotion

Terms and Conditions:

- To be eligible for the United States to Nicaragua Fee-Free on First Transfer + Discount on Second Transfer promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer and second transfer from United States to Nicaragua during the Promotion Period (each a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

- **Fee-free transfer conditions.**

- The 0 fee transfer will be directly applied to your first successfully completed transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

- **Transfer discount conditions.**

- Once you have successfully completed your first qualifying transfer, The \$5 transfer discount will be applied by Remitly directly to your second successfully completed qualifying transfer when you send \$30 or more .

- Please note that your discount amount will not count towards any minimum spend requirements.

- The transfer discount cannot be used on subsequent transfers.
