

## **\*\*The Serbia Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the Serbia Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Serbia.

- All FX rates are subject to change from time to time at Remitly's discretion.
