

The Canada to Uganda Capped Special FX Promotion

Terms and Conditions:

- To be eligible for the Canada to Uganda Capped Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Uganda.

- **The Promotion is available for first time customers only and is limited to one (1) per person. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.**

- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods, will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion.

- The Promotion will entitle eligible customers to: make one (1) transfer to Uganda at the foreign exchange rate (the "Special FX Rate") published on Remitly's Special FX branded landing page or mobile application that linked to these Terms and Conditions for up to \$500 (the "Promotion Cap").

- **Special FX Rate Conditions.** The Special FX Rate will be applied by Remitly directly to your qualifying transfer up to the Promotion Cap. The Special FX Rate is valid for qualifying transfers submitted during the Promotion Period and must successfully complete to be eligible for the Special FX Rate. If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers. If you send more than the the Promotion Cap, then Remitly's Every Day Rate (non-promotional rate), as published on Remitly's site at the time the transfer is submitted, will apply to the amount sent over the Promotion Cap.

- A transfer is considered "successfully completed" when funds are deposited into your intended recipient's bank account. If the transaction is not successfully completed, the Special FX Rate available at the time of initiation will not be applied to any future transfers.

- Amounts sent in excess of the Promotion Cap will sent at the FX Rate applicable to the service selected by you at the time of your transaction.

- All FX rates are subject to change from time to time at Remitly's discretion.

- Your election to participate in the Promotion will render you ineligible for participation in other promotions that Remitly may run and that you may otherwise have been eligible for. Your election to participate in the Promotion is final.

- The Promotion will be valid for qualifying transfers submitted during the Promotion Period. The "Promotion Period" begins on marzo 25° 2025 at 12:00 AM Pacific Standard Time and ends at 11:59 PM Pacific Standard Time on dicembre 31° 2026. Remitly's server is the official clock for the Promotion.
