

The Stati Uniti d'America to Uruguay Two (2) 0-Fees Transaction Promotion

Terms and Conditions:

- To be eligible for the Stati Uniti d'America to Uruguay Two (2) 0-Fees Transaction promotion ("Promotion") you must sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer to Uruguay during the Promotion Period ((a "qualifying transfer").
