

The オーストラリア to インド Zero-fee Transaction Promotion

Terms and Conditions:

- To be eligible for the オーストラリア to インド Zero-fee Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's zero-fee transaction-branded landing page and successfully complete your first transfer to インド.
- The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.
