

The サウジアラビア Special FX Promotion

Terms and Conditions:

- To be eligible for サウジアラビア Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to サウジアラビア.

- **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.**

- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods, will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion.

- **Special FX Rate Conditions.** The Special FX Rate will be applied by Remitly directly to your Qualifying Transfer and cannot be used on subsequent transfers. The Special FX Rate is subject to change from time to time at Remitly's discretion. The Promotion will be valid for Qualifying Transfers submitted during the Promotion Period. The Qualifying Transfer must be Successfully Completed to be eligible for the Special FX Rate.
