

The カナダ to 中国 Capped Special FX Promotion

Terms and Conditions:

- To be eligible for the カナダ to 中国 Capped Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 中国.

- **Special FX Rate Conditions.** The Special FX Rate will be applied by Remitly directly to your qualifying transfer up to the Promotion Cap. The Special FX Rate is valid for qualifying transfers submitted during the Promotion Period and must successfully complete to be eligible for the Special FX Rate. If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers. If you send more than the the Promotion Cap, then Remitly's Every Day Rate (non-promotional rate), as published on Remitly's site at the time the transfer is submitted, will apply to the amount sent over the Promotion Cap.
