

The Canada to WeChat in China Special FX Promotion Terms and Conditions:

- To be eligible for the Canada to WeChat in China Special FX Promotion ("Promotion") you must: sign in via the screen which linked you to these terms and successfully complete a transfer sending from the Canada to a WeChat user in China during the Promotion Period (such successfully completed transfer is a "qualifying transfer"). The special foreign exchange rate will be applied by Remitly directly to your first qualifying transfer.

- For a transfer to be considered "successfully completed", the transfer must be deposited in your intended recipient's WeChat account. Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for existing customers only and is limited to one (1) per person. First-time customers are not eligible for this Promotion.

- This Promotion has no cash value and cannot be transferred.

- The Promotion begins on December 11, 2022 at 03:00 PM Pacific Standard Time and ends at 03:00 PM Pacific Standard Time on December 12, 2022 ("Promotion Period"). Remitly's server is the official clock for this Promotion. All dates are subject to change. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.

- Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion (acting reasonably).
