

## **\*\*The カナダ to ドミニカ共和国 Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the カナダ to ドミニカ共和国 Special FX + Two (2) 0-Fees Transaction promotion (“Promotion”) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from カナダ to ドミニカ共和国 during the Promotion Period (a “qualifying transfer”).

- Amounts sent in excess of the Promotion Cap will be sent at the foreign exchange rate normally applicable to the service selected by you at the time of the your transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.
