

****The カナダ to メキシコ Special FX + Two (2) 0-Fees Transaction Promotion****

****Terms and Conditions:****

- To be eligible for the カナダ to メキシコ Special FX + Two (2) 0-Fees Transaction promotion (“Promotion”) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from カナダ to メキシコ during the Promotion Period (a “qualifying transfer”).
