

****The リヒテンシュタイン Special FX Promotion****

****Terms and Conditions:****

- To be eligible for the リヒテンシュタイン Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to リヒテンシュタイン.

If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers.
