

## **\*\*The マダガスカル Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the マダガスカル Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to マダガスカル.

The Special FX Rate is valid for qualifying transfers submitted during the Promotion Period and must successfully complete to be eligible for the Special FX Rate. If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers.

- A transfer is considered "successfully completed" when funds are deposited into your intended recipient's bank account. If the transaction is not successfully completed, the Special FX Rate available at the time of initiation will not be applied to any future transfers.

- Amounts sent in excess of the Promotion Cap will be sent at the FX Rate applicable to the service selected by you at the time of your transaction.
