

****The フランス to ブラジル Special FX + Two (2) 0-Fees Transaction Promotion****

****Terms and Conditions:****

- To be eligible for the フランス to ブラジル Special FX + Two (2) 0-Fees Transaction promotion (“Promotion”) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from フランス to ブラジル during the Promotion Period (a “qualifying transfer”).
