

## **\*\*The サンマリノ Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the サンマリノ Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to サンマリノ.
