

## **\*\*The エクアドル Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the エクアドル Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to エクアドル.

If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers.
