

## **\*\*The 아랍에미리트 to 필리핀 Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the 아랍에미리트 to 필리핀 Special FX + Two (2) 0-Fees Transaction promotion (“Promotion”) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from 아랍에미리트 to 필리핀 during the Promotion Period (a “qualifying transfer”).
