

## **\*\*The 룡셈부르크 Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the 룡셈부르크 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 룡셈부르크.
