

The 리히텐슈타인 Special FX Promotion

Terms and Conditions:

- To be eligible for 리히텐슈타인 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 리히텐슈타인.

The Qualifying Transfer must be Successfully Completed to be eligible for the Special FX Rate.

- A transfer is considered "**Successfully Completed**" when funds are deposited into your intended recipient's bank account. If the transaction is not Successfully Completed, the Special FX Rate available at the time of initiation will not be applied to any future transfers.
