

## The 나미비아 Special FX Promotion

### Terms and Conditions:

- To be eligible for 나미비아 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 나미비아.
