

The 북마케도니아 Special FX Promotion

Terms and Conditions:

- To be eligible for 데나르 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 데나르.
