

The 산마리노 Special FX Promotion

Terms and Conditions:

- To be eligible for 산마리노 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 산마리노.
