

The 사우디아라비아 Special FX Promotion

Terms and Conditions:

- To be eligible for 사우디아라비아 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 사우디아라비아.
