

## **\*\*The 세이셀 Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the 세이셀 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 세이셀.
