

# The New Customer Transfer Discount Offer Code Promotion

## Terms and Conditions:

- To be eligible for the New Customer Transfer Discount Offer Code promotion ("Promotion") you must redeem the respective transfer discount offer code via the notification that linked you to these terms or enter the respective transfer discount offer code at the "Redeem Offer" page when signed in to your Remitly account and successfully complete your first transfer during the respective Promotion Period as more fully described in the transfer discount offer code messaging that linked you to these terms (such successfully completed transfer is a "qualifying transfer").

- Transfer Discount Offer Code Conditions. After you redeem a transfer discount offer code for this Promotion, the respective transfer discount will be applied by Remitly to your qualifying transfer if it is successfully completed during the respective Promotion Period. Please note that your discount amount will not count towards the minimum spend requirements. The transfer discount cannot be used on subsequent transfers.

- The Promotion and any respective transfer discount has no cash value and

cannot be transferred.
