

## **\*\*The 짐바브웨 Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the 짐바브웨 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 짐바브웨.
