

****The 프랑스 to 브라질 Special FX + Two (2) 0-Fees Transaction Promotion****

****Terms and Conditions:****

- To be eligible for the 프랑스 to 브라질 Special FX + Two (2) 0-Fees Transaction promotion (“Promotion”) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from 프랑스 to 브라질 during the Promotion Period (a “qualifying transfer”).
