

## **\*\*The 뉴질랜드 to 인도 Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the 뉴질랜드 to 인도 Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from 뉴질랜드 to 인도 during the Promotion Period (a "qualifying transfer").
