

## The 미국 to 니카라과 Fee-Free on First Transfer + Discount on Second Transfer Promotion

### Terms and Conditions:

- To be eligible for the 미국 to 니카라과 Fee-Free on First Transfer + Discount on Second Transfer promotion (“Promotion”) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer and second transfer from 미국 to 니카라과 during the Promotion Period (each a “qualifying transfer”).

- Once you have successfully completed your first qualifying transfer, The \$5 transfer discount will be applied by Remitly directly to your second successfully completed qualifying transfer when you send \$30 or more .

- Please note that your discount amount will not count towards any minimum spend requirements.

- The transfer discount cannot be used on subsequent transfers.
