

## The Litouwen Special FX Promotion

### Terms and Conditions:

- To be eligible for Litouwen Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Litouwen.

The Qualifying Transfer must be Successfully Completed to be eligible for the Special FX Rate.
