

****The Nieuw-Zeeland to India Special FX + Two (2) 0-Fees Transaction Promotion****

****Terms and Conditions:****

- To be eligible for the Nieuw-Zeeland to India Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Nieuw-Zeeland to India during the Promotion Period (a "qualifying transfer").
