

## **\*\*The Namibië Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the Namibië Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Namibië.

- **Special FX Rate Conditions.** The Special FX Rate will be applied by Remitly directly to your qualifying transfer up to the Promotion Cap. If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers.
