****Terms and Conditions:****

- **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.**

- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. - The Promotion will entitle eligible customers to: make one (1) transfer to Portugal at the foreign exchange rate (the "Special FX Rate") published on Remitly's Special FX branded landing page or mobile application that linked to these Terms and Conditions for up to € (the "Promotion Cap").

- **Special FX Rate Conditions.** The Special FX Rate will be applied by Remitly directly to your qualifying transfer up to the Promotion Cap. If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers.

- A transfer is considered "successfully completed" when funds are deposited into your intended recipient's bank account. If the transaction is not successfully completed, the Special FX Rate available at the time of initiation will not be applied to any future transfers.
