

****The Saoedi-Arabië Special FX Promotion****

****Terms and Conditions:****

- To be eligible for the Saoedi-Arabië Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Saoedi-Arabië.

- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers.
