

## **The de Verenigde Staten to Ecuador Serial Transaction Promotion Terms and Conditions:**

- To be eligible for the Serial Transaction promotion ("Promotion") you must sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer to Ecuador during the Promotion Period (a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the cash sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

- **The 2 0-fee transfer(s) will be directly applied to your next 2 successfully completed transactions.**

- This Promotion has no cash value and cannot be transferred.

- The Promotion begins on september 24ste 2019 at 9:00 AM PST and ends at 5:00 PM PST on december 31ste 2024 ("Promotion Period"). Remitly's server is the official clock for this Promotion. All dates are subject to change. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.

- Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive.
