

****The de Verenigde Staten to Litouwen Special FX Transaction Promotion****

****Terms and Conditions:****

- To be eligible for the de Verenigde Staten to Litouwen Special FX Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to the Litouwen (a "qualifying transfer").

Amounts sent in excess of the Promotion Cap will be sent at the foreign exchange rate normally applicable to the service selected by you at the time of your transaction.

- A transfer is considered "successfully completed" when funds are either deposited into your intended recipient's bank account or debit card, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- All FX rates are subject to change from time to time at Remitly's

discretion.
