

The de Verenigde Staten to Nicaragua Fee-Free on First Transfer + Discount on Second Transfer Promotion

Terms and Conditions:

- To be eligible for the de Verenigde Staten to Nicaragua Fee-Free on First Transfer + Discount on Second Transfer promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer and second transfer from de Verenigde Staten to Nicaragua during the Promotion Period (each a "qualifying transfer").
