

The Wyspy Zielonego Przylądka Special FX Promotion

Terms and Conditions:

- To be eligible for Wysp Zielonego Przylądka Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Wysp Zielonego Przylądka.
