

****The Wielka Brytania to Special FX + Two (2) Fee-Free Transaction Promotion****

- To be eligible for the Wielka Brytania to Special FX + Two (2) Fee-Free Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Wielka Brytania to during the Promotion Period (a "qualifying transfer").
