

## **\*\*Existing Customer Transfer Bonus Sending to Alipay Promotion\*\***

### **Terms and Conditions:**

- To be eligible for the Existing Customer Transfer Bonus Sending to Alipay Promotion ("Promotion") you must redeem the respective transfer bonus offer code via the notification that linked you to these terms or enter the respective transfer bonus offer code at a "Redeem Offer" or "Apply an Offer" page when signed in to your Remitly account and successfully complete a transfer of \$/£/€ 500 or DKK/NOK/SEK 3500 or more as more fully described in the notification that linked you to these terms (the "Minimum Spend") to an Alipay user in China during the Promotion Period (such successfully completed transfer is a "qualifying transfer").

- A transfer is considered "successfully completed" when funds are deposited into your intended recipient's Alipay mobile wallet. Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for existing customers only and is limited to one (1) per person. First-time customers and US customers are not eligible for this Promotion.

- The Promotion begins on March 15, 2022 at 12:01 PM Pacific Standard Time and ends the earlier of 11:59 PM Pacific Standard Time on April 15, 2022 or while supplies last ("Promotion Period"). Remitly's server is the official clock for this Promotion. All dates are subject to change. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.

- Transfer bonus offer code conditions. After you redeem the transfer bonus offer code for this Promotion, the respective \$/£ 5, €4, or DKK/NOK/SEK 35 transfer bonus will be applied by Remitly directly to your qualifying transfer and will be available only to that transfer if it is successfully completed. Please note that your bonus amount will not count towards the Minimum Spend requirements. The transfer bonus cannot be used on subsequent transfers.

- This Promotion has no cash value and cannot be transferred.

- Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive.
