Terms and Conditions:

- To be eligible for the AUTO-EG-FREE-TXN-LTU-CIV promotion ("Promotion") you must sign in via the screen which linked you to these terms and successfully complete a transfer to Wybrzeże Kości Słoniowej during the Promotion Period (a "qualifying transfer").

- **0 fee transfer(s) conditions.**

- The 0 fee transfer will be directly applied to your first successfully completed transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

Transfer discount conditions.

- The transfer discount will be applied by Remitly directly to your second successfully completed qualifying transfer.

- Please note that your discount amount will not count towards the minimum spend requirements.

- The transfer discount cannot be used on subsequent transfers.

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the cash sent is picked up by the recipient at one of our partner locations (as the case may be).
